

Chamber Ribbon Cutting Guidelines

We know you have many reasons to celebrate, and we're here to make it special! As a valued member in good standing, you're eligible for a complimentary ribbon cutting every five years to showcase your business to Chamber Ambassadors and the community. Need more celebrations within that timeframe? Additional ribbon cuttings can be booked as enhanced events.

What qualifies for a standard ribbon cutting?

- Grand Openings & Re-Openings
- Expansions or Remodels
- Significant Anniversary (5, 10, 25 years, etc.)
- New Ownership
- Rebranding or Significant Name Changes
- Groundbreakings
- New Chamber Members

What the Chamber provides:

- Sends invitations to Chamber Ambassadors to attend your event.
- Arrives 10–15 minutes early to set up and introduce you to the Ambassador Chairman.
- Supplies giant scissors and a ribbon for the ceremony (you may provide your own ribbon in a custom color or size if desired).
- Attends the event and captures photos of the celebration.
- Shares the ribbon cutting on the Chamber's social media channels, reaching over 30,000 followers.

Scheduling Guidelines:

- Submit the form at least two to three weeks in advance. **Please note that your ribbon cutting is not officially scheduled until the completed form is returned.**
- Ribbon cuttings are scheduled for Tuesdays or Thursdays at 11 a.m. or 4 p.m.
- Only one ribbon-cutting ceremony per day; not available on Chamber event days.

Enhanced Ribbon Cutting Option – \$175

Elevate your celebration with our Enhanced Ribbon Cutting, which includes:

- **Social media content:** Chamber staff will create and share an Instagram reel of your event, in addition to our standard post.
- **Confetti cannons:** Optional confetti cannons add a festive touch to your ceremony.
- **Public calendar listing:** Your event will appear on the Chamber's public calendar for greater visibility.
- **Newsletter feature:** Your ribbon cutting will be highlighted in our "This Week at the Chamber" e-newsletter, reaching more than 7,500 local business contacts the week of your ceremony.
- **Photo access:** All photos taken by Chamber staff will be available to you via an Adobe link.
- **VIP invitations:** Our team can assist in sending invitations to VIP guests.

Enhanced ribbon cuttings are complimentary for Legacy of Leadership sponsors and members of the board of directors. Each new member is eligible for one standard ribbon cutting, with an additional complimentary standard ceremony every five years.
